- Explain the state and federal reporting laws
- List elements of effective trauma-informed screening procedures

Module 4: Resourcing & Training

- Describe important messages to convey to potential victims
- List the elements of response for safety, emergency, and reporting requirements
- Recite the National Human Trafficking Hotline number and some of the resources they provide
- List common short and long-term needs for victims
- Describe the importance of building resource networks
